



## Give the Gift of Camp Invention Sweepstakes (the “Sweepstakes”) Official Rules

In addition, You agree to accept the decisions of the National Inventors Hall of Fame as final and binding as it relates to the content of this Sweepstakes. You further understand and agree that any violation of these Official Rules will result in Your disqualification and forfeiture of any prize.
- Eligibility. The Sweepstakes is only open to legal U.S. residents age 18 or older and is void where prohibited by law. Employees of the National Inventors Hall of Fame, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstakes. Your email must include your first and last name, phone number and email address. Entries will be accepted from 10/01/24 through 12/31/24 at 11:59 p.m. PST. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the National Inventors Hall of Fame.

Ten (10) winners will receive either: (1) a refund of their 2025 Camp Invention registration fee if they have already registered or (2) free registration for a 2025 Camp Invention camp if the winner has not already registered. Limit of (1) prize per household. The approximate retail value of each prize is \$275.
